

Flowers, Flags, Etc.:

Flowers, florals, etc. are not to be placed in alcohol or other preservatives.

No glass vases of any type are allowed.

No wire hangers for holding plants are allowed.

When flags, flowers or wreaths become wilted or unsightly, the same shall be immediately removed.

No trees, shrubs, flowers, etc. shall be planted on any grave plot except by the Town of Rural Hall.

Resale of Grave Plots:

Grave plots cannot be purchased for the purpose of resale.

Any purchaser desiring to surrender his/her rights to a grave plot, may do so by delivering his/her certificate to the Town of Rural Hall. The Town of Rural Hall will then attempt to sell the grave plot to another individual for the original price of the grave plot.

Interments:

Interments will be conducted during daylight hours only.

Interments will not be allowed on Easter Sunday nor Christmas Day.

Only interments of human remains will be permitted.

Only one interment shall be made in a single grave plot.

No more than one person shall be interred in a single grave plot.

EXCEPTIONS: Mother and infant or two children and then only when interred at the same time.

A permanent enclosure for a casket is required for all interments.

CREMATIONS: No more than two interments of cremated remains shall be allowed in one grave plot.

The Town of Rural Hall reserves the right to require that certain interments be held only in the presence of the immediate family or family member, licensed funeral director and employees of the Town of Rural Hall. Rural Hall Memorial Park will be closed at that time.

Rural Hall Memorial Park

Rural Hall Memorial Park is located on Tobaccoville Road in Rural Hall, North Carolina. The cemetery was founded in 1935 by four area churches: Kingswood United Methodist Church, Rural Hall Baptist Church, Rural Hall Church of Christ and Rural Hall Moravian Church. In 1994, the cemetery and the operations thereof were turned over to the Town of Rural Hall.

The purchase price and terms of sale for all grave plots or any services furnished by Rural Hall Memorial Park are established by the Board of Councilmen of the Town of Rural Hall.

The Town of Rural Hall will not be liable for any damages that are brought about by elements, thieves, Act of God, common enemy, vandals, strikers, malicious mischief makers, children, explosions, unavoidable accidents, invasions, riots, trespassers, etc.

The following are prohibited in Rural Hall Memorial Park:

- Visitors between dusk and dawn
- Children under 12 years in age without supervision
- Domesticated animals
- Controlled substances and alcohol
- Loud, boisterous or obscene language and improper conduct including hunting, camping, etc.
- Playing or sitting on headstones or monuments
- Firearms; except, officers of the law or members of military detail
- Peddling, begging, soliciting or collecting
- Display or distribution of signs, cards, handbills, circulars, etc.
- Speeding
- Bicycles, motorcycles, sleds, toy wagons, coasters, roller blades, roller skates, skateboards, etc.; except, motorcycle police officers
- Littering
- Trespassing
- Parking or leaving vehicles; except for visitation or attendance of a funeral service
- Trimming, pruning or removing branches from trees and shrubs
- Scratching, marring, defacing, injuring or disturbing any monument, headstone, footstone, building, etc.
- Placing of coping, fencing, borders, corner posts, curbing, hedging, etc.
- Delivery trucks; except, those delivering flowers to an interment or grave and licensed memorialist.

List of Fees:

**Grave Plots for residents inside
Rural Hall town limits:** \$500.00

**Grave Plots for residents outside
Rural Hall town limits:** \$3,000.00

Baby Plots (up to 5 years in age):
\$250.00 for residents inside Rural Hall town limits; \$500.00 for residents outside Rural Hall town limits.

Permanent Marker Deposit: \$400.00 to be paid at the time of burial. This deposit is refundable if a stone is erected within 6 months of burial. If a marker is already erected, \$300.00 must be paid at time of burial. This deposit is refundable if proper lettering is completed within 6 months of burial. (These fees are payable by both inside and outside residents in addition to the price of a grave plot.)

All fees are to be paid in full when a grave plot is purchased. **EXCEPTION:** Permanent Marker Deposits are paid at the time of death.

No reservations for future sale on a grave plot will be recognized.
